

Commerce Lexington's economic development team is seeing this reflected in the RFIs we are responding to and in existing business expansions, such as the recent Toyota Georgetown investment and the Hitachi Astemo investment in Berea.

Lexington-Fayette Urban County Government Extends Economic Partnership

In June, our team presented a year-end summary report that outlined the success of our program efforts to LFUCG's Economic Development Investment Board (EDIB). The EDIB voted to extend grant funding for an additional year, Fiscal Year 2023, continuing support of our

economic development initiatives. On behalf of Commerce Lexington, we thank LFUCG for trusting in our services and for dedication to the business community.



Lexington Receives Perfect Score on Long-term Support

The Financial Times-Nikkei US City FDI Rankings is an annual report that ranks cities in the United States by their success in attracting foreign direct investment (FDI). The report evaluates cities based on several factors including FDI strategy, economic potential, business friendliness, human capital and lifestyle, and connectivity. Out of a 100 score, Lexington scored a perfect 100 on aftercare, which is based on a survey of the city's long-term support of existing companies. Workforce and talent are among top concerns for foreign investors. The chart shows the importance of a college educated population for companies considering locations. Commerce Lexington's Economic Development team contacts over 150 businesses within the community each year to provide support for the various challenges and opportunities companies face in their efforts to grow and prosper in Central Kentucky.

Toyota Announces Expansion for Electric Vehicle Production

Toyota continues their commitment to Central Kentucky by selecting the Georgetown facility to produce their first BEV in North America. All-new, three-row, battery electric SUVs will begin rolling off the lines in 2025. Opened more than 36 years ago, the factory in Georgetown represents the largest Toyota manufacturing facility in the world and provides quality jobs to more than 9,000 Kentuckians. Annually more than 550,000 vehicles a year are produced in Georgetown, including the Avalon, Avalon Hybrid, Camry, Camry Hybrid and the Lexus ES 350. We are proud to have Toyota Motor Manufacturing as part of the Central Kentucky Business Community.



Legacy Business Park Receives KPDI Funding

Designed to support upgrades to industrial sites around the state, the Kentucky Product Development Initiative (KPDI) includes \$100 million in state funding which can be accessed by communities to make existing sites more attractive for potential projects.

Lexington applied for and secured \$2 Million in funding from the KPDI program for the 200-acre Legacy Business Park located along I-64/I-75 near the Coldstream Research Campus. Work will begin later this year to extend and improve infrastructure to the site. In total, more than \$6 million in improvements will be made to the site.



Tipman Locates Sales and Distribution Office in Lexington

Tipman, a Japanese-based company that manufactures and sells equipment for arc welding, has located in Lexington and joined the area business community with a sales and distribution office. Their main customers are the automotive and construction industries. According to company officials, Kentucky's dominance in the automotive industry, as well as Lexington's transportation network and low cost of doing business, made the area an attractive choice for Tipman to grow their U.S. customer base. Business & Education Network Joins National Initiative to Expand Access to College and Career Pathways

Commerce Lexington is partnering with the Kentucky Council on Postsecondary Education (CPE) in a new national initiative known



as Launch: Equitable & Accelerated Pathways for All. The program aims to expand access to high-quality and equitable college and career pathways for all learners.

Commerce Lexington is one of 10 state partners, which include the Kentucky Department of Education, Kentuckiana Works, Kentucky Center for Statistics, Kentucky Chamber of Commerce, Kentucky Community and Technical College System, Kentucky Education and Labor Cabinet, Fayette County Public Schools, Jefferson County Public Schools and Shelby County Public Schools.

To tackle this challenge head-on, five leading organizations including Advance CTE, Education Strategy Group, ExcelinEd, Jobs for the Future (JFF) and New America, with support from the Annie E. Casey Foundation, Bill & Melinda Gates Foundation, Bloomberg Philanthropies, Carnegie Corporation, Joyce Foundation, and the Walton Family Foundation, will be partnering with Kentucky and other cohort states to implement this important work.




Community Stakeholders Learn from Grand Rapids, Michigan on 2023 Leadership Visit

Commerce Lexington and Fayette County Public Schools Partner in "A Seat at the Table"

CMBD partnered with Fayette County Public Schools (FCPS) for "A Seat at the Table" on June 8, which featured guest speaker Rita McNeil Danish, CEO of Signal Ohio and Founder/Principal of JD2 Strategists, LLC.

Business owners learned about updates to the FCPS Board of Education's Purchasing Policy designed to increase the inclusion of Minority Business Enterprises (MBE's), Women Business Enterprises (WBE's), and Veteran Business Enterprises (VBE's). Diversity, Equity, Inclusion, and Belonging Leaders in schools will now also advocate for supplier diversity. In the fall, FCPS will present awards to Supplier Diversity Champions, recognizing schools with the greatest percentage increase in spending with MBE's, WBE's, and VBE's.

FCPS has also committed to mandatory Safe School Training modules on purchasing and supplier diversity, implementing the three-envelope system for construction bids, and fostering the newly formed partnerships with the 7PM Group and KY Apex Accelerator. A guest panel of industry experts and state legislators hosted by Emmy-winning journalist and television host Sherelle Roberts concluded the event.
