ElectraMet Marks Expansion With Ribbon Cutting & Open House

Lexington business, government and community leaders came together on May 3 to mark the expansion of PowerTech Water Inc d/b/a ElectraMet™, a water purification technology company, with a ribbon cutting and open house at its new 26,000 square foot facility. Founded in 2014 by Dr. Cameron Lippert and Dr. James Landon, the company got its start at the University of Kentucky's Center for Applied Energy Research (CAER) and later developed the ElectraMet water treatment system to offer an environmentally superior solution for industrial process and wastewater streams. Through partnerships with the University of Kentucky; investments from the Bluegrass Angels; funding from the Kentucky Enterprise Fund; and multiple grants through the Small Business Innovation Research (SBIR) program; the growth of ElectraMet showcases Lexington's capacity for innovation.

Lexmark Breaks Ground on New Solar Panel Array at Lexington HQ

On April 19, Lexmark International broke ground on its 10-acre solar panel array and educational greenspace, a \$4 million investment in sustainable energy at its corporate headquarters in Lexington. The solar array and revitalized brownfield also will be utilized to further enhance Lexmark's longstanding support

of STEM education opportunities for local schools. Commerce Lexington President and CEO, Bob Quick, said, "Lexmark has been a longtime community partner and economic driver in Central Kentucky. Its team has not only developed innovative solutions for business but has also demonstrated that a business model focused on environmental sustainability can succeed, resulting in a positive impact on our people, our community and the planet," Quick said. 

Tech Employer Roundtable Discussion

In April, the Commerce Lexington Economic Development division hosted an IT Consortium with community partners Awesome Inc. and Bluegrass Area Development District to initiate a roundtable discussion with tech employers in the Lexington area. Collectively, the organizations and employers aimed to assess ideal skill sets and experience necessary for a job seeker to have a competitive edge finding employment with the industry and for an employer to have confidence in the Bluegrass Regions' candidate pool. The discussion prompted exploratory ideas and required actions items for further development.



Commerce Lexington Maintains Regional Location Analysis Data Tool

In June, the Bluegrass Alliance met at Commerce Lexington to discuss prospect activity and shared issues facing each community. The regional partners were shown features of a new site selection tool called Zoom Prospector on the Locate in Lexington website. This interactive tool aggregates data from the nine counties in the Bluegrass Alliance region to be used for new prospect activity and to support existing business expansion projects. Users can generate detailed reports on properties, industry clusters, labor force and demographic statistics, as well as explore communities in the region by utilizing an enhanced mapping tool. The group closed out the meeting with a discussion on planning an event and trip later this year.

The population and labor force of the Bluegrass Alliance region is 30% larger than the MSA, at close to 700,000 and over 345,000, respectively.

Board announced a \$300,000 award to Commerce Lexington for Fiscal Year 2023 to execute business development services for the Lexington Economic Partnership. Through this partnership, our team serves as Lexington-Fayette Urban County Government's resource for economic development, with a focus on new business development and job creation, existing business retention and expansion, and minority business development. The ability to provide these services is bolstered by our multi-year capital campaign, the Full Stride Initiative. KCED Tour of Legacy Business Park and Coldstream Research Park Campus

In early May, team members from Commerce Lexington and the Kentucky Cabinet for Economic Development toured The Legacy Business Park and Coldstream Research Campus. The Lexington Fayette Urban County Government acquired these sites through a historic 'land swap' with the University of Kentucky to provide Lexington with a competitive edge to attract new businesses and grow new jobs within Lexington's urban service boundary. The tour concluded at Kentucky Eagle to share feedback and continue conversation about current and prospective economic development opportunities.

C2ER/LMI Institute Annual Conference and Forum



The economic development team traveled to Columbus, Ohio, in mid-June for the annual conference and forum for the C2ER/LMI Institute. The C2ER and LMI networks consist of research professionals in the U.S. and Canada representing all aspects of community and economic development along with labor market data. Conference highlights included industry-leading keynotes, training classes and breakout sessions, a regional Economic Researchers' Roundtable, and opportunities to build important networks within the research community.

BEN Launches “Accelerate Lexington” Training Program to Address Workforce Issues

The Business and Education Network (BEN) partnered with the Lexington Fayette Urban County Government (LFUCG), Bluegrass Community & Technical College (BCTC), CHI Saint Joseph Health, Baptist Health and UK Healthcare to launch “Accelerate Lexington,” a fully paid Certified Nursing Assistant (CNA) training program for selected candidates. This eight-week pilot program was born in response to the healthcare worker shortage in Kentucky and began with an informational event on May 18th.

The pandemic has overwhelmed the healthcare industry, leading to a mass exodus of healthcare workers. “National turnover for Certified Nursing Assistants (CNA) was at 35.5% in 2021, which according to NSI Nursing Solutions, is an 8% year-over-year increase. That outpaces all other measured positions when it comes to turnover,” said Lynette Walker, incoming BEN Board Chair and Regional Vice President, HR, for Baptist Health Lexington.

The “Accelerate Lexington” training program is designed to combat this workforce issue and incentivize Central Kentucky residents to enter the medical field. Over 80 people attended an informational event at BCTC’s Leestown Campus to meet with participating healthcare employers and learn more about the CNA profession. 30 participants were selected to take part in this inaugural program and classes began on June 13th.

The selected participants matched with a healthcare provider and will receive fully paid training, a nursing assistant certification and full-time employment with that healthcare provider once the training is complete. “At a time when communities across the country are struggling to retain talent, it’s exciting to be part of this collaboration that will remove barriers to employment and help our residents jumpstart their healthcare careers in Lexington,” said Commerce Lexington President Bob Quick.

As a partnership between the Lexington Fayette Urban Government and Commerce Lexington, the “Accelerate Lexington” training program is the maiden talent recruitment effort of a larger entity entitled The Lex Factor, which is an initiative of Commerce Lexington’s Business and Education Network. Based on the success of the “Accelerate Lexington” CNA pilot program, this model can be repeated in other industries of need in Central Kentucky. The Lex Factor’s recruitment initiatives will be a solution to the broader workforce shortages in Central Kentucky, making Lexington and the surrounding counties a hub for all things work, play and everything in between. Commerce Lexington Participates in Turner UK Construction Diversity Accelerator

Commerce Lexington was a significant community partner and program supporter in the Turner UK Construction Diversity Accelerator, which ended in May. Our goal was to be a part of a training that provided women and minority-owned construction related businesses the tools they would need to create significant partnerships with large constructors and grow their businesses in a more sustainable way. The 10-week program had over 20 program presenters. Program participants received weekly sessions on Key Construction Topics, Networking & Business Connections, One-on-One Coaching, Capability Statement Support, access to resources and bidding opportunities, and a professional headshot. Programming ended with a mock bid presentation. In total, 11 companies graduated and took part in the mock bid presentation.

Commerce Lexington Recognized for FDIC’s “Money Smart for Small Business” Classes

In April, Commerce Lexington was recognized for their work in conducting the Money Smart for Small Business classes. As a result, Tyrone Tyra was invited as a guest panelist in the FDIC’s national Money Smart for Small Business Town Hall Webinar held on April 28th. Tyrone showcased how Commerce Lexington has worked with financial institution partners and other community-based organizations to promote economic inclusion. The national event was viewed by aspiring entrepreneurs, existing small businesses, community-based organizations, financial institutions, and FDIC Money Smart Alliance members.



Commerce Lexington Senior Staff Meets with Morehouse College School of Medicine

In April, Tyrone and other members of the senior staff met with five members of the Morehouse College Medical Team. Morehouse School of Medicine is a private co-educational medical school in Atlanta, Georgia. Originally a part of Morehouse College, the school became independent in 1981. The group was in town investigating the business environment, seeking partnerships, and scouting living opportunities for their upcoming “residence in training” program. The program partner in Lexington will be St. Joseph Hospital and Lexington Clinic. Residents will practice medicine in the emergency room and cardiac care over a two-year period to obtain hands-on experience alongside St. Joseph and Lexington Clinic physicians.
